1800 INTRO: · Welcome to Paul in Prison: 10 weeks exploring the background of the Prison Epistles • This is to supplement and "add texture" to the Sunday morning sermon series The approach will me a combination of presenter input, but also student participation. · I believe you learn most when you participate in the learning process. · KN-The outline for the class will be as follows **OVERVIEW OF SESSION** 1805 Tonight we are going to look at the circumstances that led up to Paul's Roman imprisonment. This was not the first time Paul had been in custody. You remember that during his second missionary journey he was imprisoned and miraculously delivered in Philippi. Leading up to his Roman imprisonment, he was in custody in Caesarea for two years a situation we will explore tonight. Then he was imprisoned in Rome for two years. The book of Acts ends with him in prison there, but most Bible scholars believe that he was eventually released, and may have made another missionary journey (which they piece together using information from the epistles). He was imprisoned a second time in Rome, this time at the Mamertine Prison, where he was ultimately executed. 1810 **FOCUS** · Tonight we will focus on the what is called the Roman Imprisonment from which he wrote the prison epistles. • My goal is for us is to get into the story by taking on the role of a particular character in the narrative. I want you to see the event(s) from their perspective and feel their emotions as they and their associates participated in the event. I want them to become real people form real places in real situations with real feelings. · So, we are going to interview six characters from the story to get insight into the events, issues and outcomes from them. · You are going to play the parts. I am going to assign six groups to prep a person for the interview. - 4. As heard Paul speak to that body, why did you order him struck? What was your take on the speech?
- 5. What was the controversy that arose between the Pharisees and Sadducees on the council?

- 7. You eventually sent Paul out of town. Where did you send him and why?
- 8. Tell us about the letter you sent with him.
